### **Domain Registration**

#### **Initial Buildout**

641tech will provide a website for the Leonardo Corporation hosted at ecatthenewfire.com. The website will be hosted on Wordpress, an open source content management system. It will use a number of free plugins to extend the functionality of the Wordpress website. The server hosting the web server will be hosted on cloud infrastructure hosted in the United States of America. 641Tech can include integrations for YouTube, Facebook chat, and Google Analytics. Other features can be requested as well not guaranteed. The buildout of the website will be a one time charge listed in the Cost of Services section below.

## **Continuous Operations**
